It is also the responsibility of individual members to notify changes in their registered interests within one calendar month of the change occurring.

This register will be retained by Democratic Services and available for Departmental and Audit Inspection.

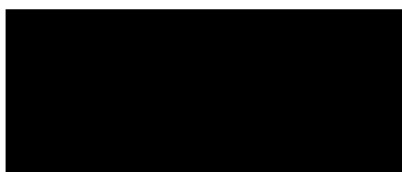
