The policy allows for household waste collection from every household in the Borough. This includes

- · Residual waste
- · Mixed dry recyclables
- Compostables (food/garden)
- Glass

The Council operates a kerbside/roadside collection service. Bins and glass boxes must be presented at the kerbside for collection on the designated collection day from 7.00am. After collection, the bin/box will be returned to the collection point and must be removed by the householder on the day of collection to avoid the potential of theft, damage or causing an obstruction.

An assisted collection service is available on request, for any person who has difficulty presenting their bin for collection on medical grounds. Council currently operate 1910 assisted lifts throughout the Borough

In the event that the collection crew cannot gain access to the street or road due to circumstances beyond their control such as blocked access due to parked cars, road works or a road traffic accident, the Council will provide an alternative collection on the next day. If a householder fails to present their bin for collection on the appropriate day, the Council is under no obligation to make alternative collection arrangements. Damaged, overloaded and/or grossly contaminated wheeled bins will not be collected by the Council.

Ards and North Down Bough have a significantly higher population of older people in comparison to Northern Ireland as a whole (NI 17%) AND had the largest increase in the number of people aged 65 and over. This rose from 27,692

(17.7%) in 2011 to 36,226 (22.1%) in 2021,

demonstrating the scale of population change due to ageing.

Disability evidence 41,300 or 25.3% of people in Ards and North Down had a

limiting long-term health problem or disability. Ards & North Down experienced an increase of 31.4% from 2011. These changes are in part a reflection of the Boroughs ageing

population.

Figures show that 7.2 per cent of the Borough have deafness or partial hearing loss, 68% being over the age of 65.2% have blindness or partial sight loss, 11% of those people are aged

0-39 years.

1.6 % have mobility or dexterity difficulty that requires the use of a wheelchair, in comparison to Northern Ireland statics this means that 9.3% of all those who have mobility or dexterity difficulty that requires the use of a wheelchair reside in the

Borough.

0.8% have an intellectual or learning disability including

dyslexia and Downs Syndrome.

1.6% have Autism or Asperger syndrome, 49% are between 0-14 years whilst 40% are aged 15- 39 year. 8.1 % have an emotional, psychological or mental health condition, includes



depression and schizophrenia, this is highest in the age ranges of 40 - 64 years (47%).

2% have frequent periods of confusion or memory loss, including Dementia, this is most prevalent with ages 65+. 10% of residents have another condition, for example Cancer, Heart Disease or Diabetes, again this is most prevalent in age 65+.

Taken together these results show that policy making must consider Ards and north Down aging population and health and disability issues

Dependants evidence

In Ards and North Down there were 27,822 Children (defined as those aged 0 to 14). Children make up 19.2% of the Northern Ireland population. This percentage varies across the Local Government Districts and is lowest in Ards and North Down where the proportion is 17.0%.

According to Birth statistics on NISRA Ards and North Down recorded 2,854 births between 2020 and 2022, giving an indication of the numbers using buggies or prams in use.

The Northern Ireland 2021 Census shows the Number of dependent children and Unpaid care' covers looking after, giving help or support to anyone because they have long-term physical or mental health conditions or illnesses, or problems related to old age. It does not include any activities as part of paid employment. All unpaid care statistics are restricted to persons aged 5 and over., The Census 2021 suggested one person in eight of NI population aged 5 or more (or 222,200 people) noted that they provided unpaid care. One important point to note in Policy making is that 2,600 children aged 5 to 14 in Northern Ireland provide unpaid care.

Council has been made aware that Household Collection of Bins have been causing an obstruction to people walking along the pavements, especially but not exclusively for those that are wheelchair users and those with prams.

Councils policy states:

After collection, the bin/box will be returned to the collection point and must be removed by the householder on the day of collection to avoid the potential of theft, damage or causing an obstruction. It is therefore the responsibility of the household to ensure that the bin/box is not causing an obstruction to other footpath users, in certain circumstances where there is a narrow footpath this is unavoidable. In order to mitigate this issue Council currently operates 1910 assisted lifts through out the Borough. A further mitigation maybe that Council operates a communication campaign to raise awareness of how bins on pavements affects members of the public such as wheelchair users and also those with prams.

It has been suggested that ANDBCs Kerbside collection service has a disproportionate and negative impact on those with disabilities and causes considerable problems to those with a range of disabilities. However Council has not received any complaints (logged on TASCOMI) to date to suggest this is an issue, whereby a narrow footpath exists this may force those with a disability on the road, causing a health and safety hazard.

Potential equality issues have been identified in relation to individuals with a disability as follows:

- blind and partially sighted people who are unable to read standard information materials and to whom larger collection containers on footpaths may cause obstruction difficulties.
- physically disabled people who are unable to present bins or containers for collection
- people with disabilities may have an underlying medical condition that causes additional waste to be generated and may require more capacity than the standard provision.

We also recognise that people with learning disabilities may have problems accessing information materials or impact on their ability to fully sort materials for recycling.



Age NI, Guide Dogs NI and RNIB recently identified the following potential equality issues in relation to individuals with a disability:

- larger bins will block the pavements on collection days causing risk to people living with visual impairments
- collecting glass in the recycling bins will make them heavier and pose safety concerns for people living with sight loss
- larger bin may impact on the independence of older people

It is also recognised that there is potential for larger bins presented on pavements to raise concerns amongst those with a disability who use a wheelchair.

People with multiple identities may be subject to minor disadvantage which should be mitigated by measures such as a consideration of an awareness campaign to show the dangers of obstructing footpaths. This could promote how to complain to Council if the bin is left out continually and causing an obstruction.

Monitoring Arrangements

25a. Mitigating Actions

When the Council concludes that the likely impact is 'Minor' and an equality impact assessment is not to be conducted, the Council may consider mitigation to lessen the severity of any equality impact, or the introduction of an alternative policy to better promote equality of opportunity or good relations.

The household collection service has been operational for many years with no complaints logged on Councils TASCOMI system.

Council has been made aware that bins on streets are causing a disproportionate and negative impact on those with disabilities and causing considerable problems to those with a range of disabilities and those using a pram.

It would therefore be good practice for Council to consider and operate a communication campaign, aimed at all households in the Borough to raise awareness of how bins on pavements affects all members of the public using footpaths/pavements such as wheelchair users and also those with prams. Reminding them of their obligation to remove the bin from the pavement as early as is possible for the household and reminding them of Councils assisted lift service.

It may also be beneficial to remind those employees within Waste and Cleansing service to return the bin so as not to cause an obstruction to users, where possible.

Council may wish to add an addition to the current policy to state whereby those household that do not remove their bin from the pavements on a continuous basis and a complaint is raised that the household will receive a letter reminding them of their responsibilities and their impact on footpath users.

26. Monitoring Recommendations

Once agreed by Council the process should be reviewed following public opinion on the campaign and any comments or complaint in relation to the obstructing of footpaths pavements by bins, this will give all individuals in the Borough the opportunity to highlight issues or improvement options.

Conclusion

Screening panel Comments -

I was agreed by the internal panel that there is more of an adverse impact on wheelchair users, those using Guide dogs and those with a Sight impairment. This was due to having to access the nearest dropped kerb to access the road.

Due to a lack of enforcement legislation for this issue it was agreed that Communications with householders should be used to request that bins are presented so as to minimise impact to users of public footpaths, this should be monitored and reviewed where necessary. It should be noted that no reliable data is available on sexual orientation-NISRA are currently examining methodology on how to measure this. However, the 2011 census indicates that less than 1% of the Northern Ireland adult population (those aged 16 years and over) were in a registered same-sex civil partnership. This was similar to the borough as a whole. The Continuous Household Survey in Northern Ireland estimated this figure between 0.9% and 1.9% in 2015-2016. The Office for National Statistics estimates a similar range for the United Kingdom (1.7%).
